1. Longeline Futurity open to any breed yearling exhibited by open or non-pro exhibitor. Jackpots open to any age, any breed horse shown by a non-pro exhibitor.
2. Points will be calculated using the Triple Crown Futurities Point System.
3. Entry fees are \$75/futurity or jackpot. 10% of the entry fees will be used to cover office fees and all other monies will be paid out to contestants.
4. Pre-entries are welcome but NOT required. Entries the day of the show are welcome!
5. Classes will follow APHA rules.
5. Payouts will be made after all checks have cleared the bank (please allow 3-4 weeks)
6. NO REFUNDS!
7. Youth or Amateur Card must be presented at time of entry, as proof of Non-Pro status and yearling registration papers must be presented as proof of age of the horse.
